THIS SET OF PROOFS REPRESENTS THE "APPROVAL STATE". AT THIS STAGE THE WORK ON THE ENGRAVING IS COMPLETE, IT WAS THEN SENT TO THE PROPER PERSON FOR APPROVAL. AFTER APPROVAL THE LOCATOR + MARKS WERE ADDED AT THE ENDS OF THE STAMP BY THE ENGRAVER, AND THE DIE RELEASED FOR ADDITION OF THE DIE NUMBER. THIS IS THE NEXT TO THE LAST STAGE IN THE PROGRESS PROOFS. THE "FINAL" STAGE HAS THE + MARKS.
